Treasurer's report

The current bank balances are:

Main account: £ 4784.67

Bar account: £ 5514.10

Main movements:

Income: £10 donation.

Expenses: £56.27 in respect of the WIFI, and £301.48 to Network Rail in respect of electricity for March 2020. Other bills are expected and will have to be taken into account in the balances. 2 x payments of £14.39 each for membership for Zoom.

No correspondence was received from Network Rail, although they did try to take £5842.10 for Rent and Service Charge, which was returned by the bank as it took the account overdrawn. Neither Network or the bank have contacted NTC even though this happened on the 29th December. No invoice has been received either.

FJ will be contact Network Rail again to explain and also enquire about the rent free period already mentioned.

Insurance:

RM has queried whether NTC need to pay the full insurance premium whilst the theatre is not being used.

The committee agreed with FJ's view that it would be best to continue with the current policy because if NTC are given the go ahead to open it could take some time to re instate a full policy. Also the outstanding claim has not yet been settled which needs to be taken into account.

Future Productions

On LC's suggestion it was agreed to defer this production from February until May. However It will be dependent on whether it is deemed safe to return to the theatre in May.

LC will contact all actors and directors who have registered interest and inform them of the present situation.
